This is entirely the responsibility of the Releasor to obtain and to pay for. The Releasor acknowledges, confirms and agrees that they have been advised to maintain documentation confirming their travel insurance as well as documentation of their Ontario Hospital Insurance Plan (OHIP) coverage on themselves for the duration of the event or trip at all times. The Releasor confirms, acknowledges and agrees that it is their sole responsibility to advise any eating establishment of any food allergies that they may have and to take all necessary precautions to protect themselves.
